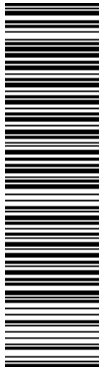

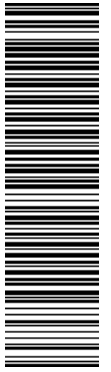

### Dominican Republic business visa checklist

- ☐ **Filled out and signed Dominican Republic business visa application form.** The form is enclosed.
- ☐ **Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- ☐ **1 Photographs.** Standard passport photographs 35mm x 45mm on a white background.
- ☐ **Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- ☐ **Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- ☐ **Birth certificate.** Birth certificate (with legalization).
- ☐ **Bank Statement.** Bank statements or other documents/information proving sufficient financial means during stay in Dominican Republic.
- ☐ **Business Letter.** Business letter from the host company in Dominican Republic explaining the purpose of the trip, dates of travel and guaranteeing sufficient funds. The letter needs to be addressed to the Consulate of Dominican Republic, dated no more than 1 month old, should include original signature.
- ☐ **Medical Certificate.** Health certificate indicating that the applicant does not suffer from any infectious/ contagious diseases.
- ☐ **Proof of profession.** Original degree/certificate/credential legalized with Apostille of The Hague and translated into Spanish by an official translator from one of these associations.

☐ **Letter of guarantee.** An original letter of guarantee of a legal person - from the company he/she is visiting in Dominican Republic (notarized with a signature of the legal person).

☐ **Police clearance.** Certificate of "good conduct" (from the Police department, with legalization).

☐ **Certificate of Labour.** Certificate from the Ministry of Labour of the Dominican Republic, containing the Resolution No. 135 (this document must be supplied by the Dominican company)

Additional Documents for Children: **Letter of Consent.** An original letter of consent signed by both parents, specifying who will be travelling with the child and authorizing the trip. All nationalities are eligible to obtain a tourist card providing they hold a valid UK, USA, Canadian or Schengen visa. All travellers are subject to a departure tax of 20 US dollars when leaving the island. No documents need to be mailed to VisaHQ for processing. You will receive your Tourist Card via Royal Mail.

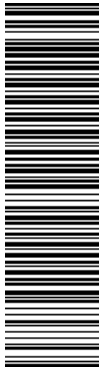
