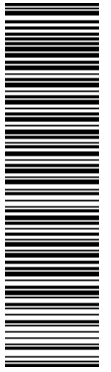

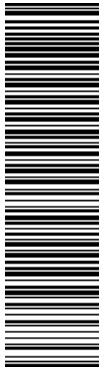


### Equatorial Guinea tourist visa checklist

- Filled out and signed Equatorial Guinea tourist visa application form.** The form is enclosed.
- Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- Passport Photo: 3** Include a passport style photo, 50mmx50mm ('2x2'), with a white background, taken within the last 6 months. You may also choose to upload a photo to your order for us to print. There is a surcharge associated with this service.
- Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- Proof of Status.** Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Equatorial Guinea.
- Itinerary.** Copy of **round trip tickets or itinerary**.
- Bank Statement.** Copy of a recent bank statement showing proof of sufficient funds.
- Letter of Invitation.** An official letter of invitation approved by the Ministry of Foreign Affairs in Equatorial Guinea.
- Police Report.** Original police report or Certificate of Good Conduct from applicant's local police station.
