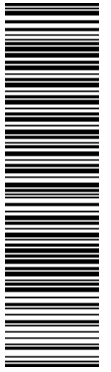

### Fiji tourist visa checklist



**Filled out and signed Fiji tourist visa application form.** The form is enclosed.



**Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.



**3 Photographs.** Standard passport photographs 35mm x 45mm on a white background.



**Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.



**Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.



**Itinerary.** Copy of **round trip tickets or itinerary**.



**Bank Statement.** Copy of last 3 months bank statement showing proof of sufficient funds.



**Hotel Reservations.** Copy of confirmed hotel reservations including name of the applicant, name and address of the hotel, duration of stay.

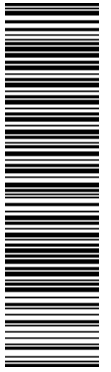


**Personal Invitation.** If visiting friends or family, you must provide letter of invitation with the contact information of the host and visitor, who is responsible for the expenses, purpose and duration of the visit, confirmation of accommodation including the address, signature and date. You will also need to provide proof of the host's status in Fiji ie. copy of their Fiji passport's information page, or, if they are not a citizen of Fiji, copies of their Fiji residence permit and their national passport's information pages.



**Police Report.** Original police report or Certificate of Good Conduct from applicant's local police station.

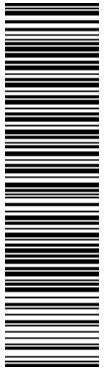

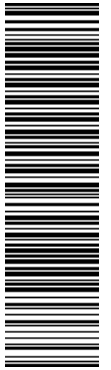
