Original Passport. Passport must have at least 6 months remaining validity and have at least 1 visa page.
2 Photographs. Standard passport photographs $35 \mathrm{~mm} \times 45 \mathrm{~mm}$ on a white background.

Payment. Credit Card Authorization form, Postal Order payable to VisaHQ.co.uk.

Return mailer. Prepaid self-addressed return label or payment for Royal Mail.

Proof of Status. Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Guadeloupe.

Itinerary. Copy of itinerary showing exact dates of travel from airline or travel agent. Please note that the number of entries on your visa will be based upon your itinerary.

Travel Insurance. Letter on company letterhead from Health Insurance Company indicating the coverage plan for the applicant, specifically stating that the applicant will be covered while traveling internationally and indicating the validity of this coverage (with a minimum medical coverage of GBP 22,000 ).

Bank Statement. Copy of a recent bank statement showing proof of sufficient funds (at least GBP 60 per day).
