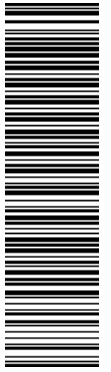

Guyana tourist visa checklist



Filled out and signed Guyana tourist visa application form. The form is enclosed.



Original Passport. Passport must have at least 6 months remaining validity and have at least 1 visa page.



2 Photographs. Standard passport photographs 35mm x 45mm on a white background.



Payment. Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.



Return mailer. Prepaid self-addressed return label or payment for Royal Mail.



Proof of Status. Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Guyana.



Itinerary. Copy of **round trip tickets or itinerary**.



Yellow Fever Vaccination. Copy of International Certificate of Vaccination for Yellow Fever.



Bank Statement. Copy of a recent bank statement showing proof of sufficient funds.



Employment Letter. An original letter from your employer/school (on business letterhead, with contact details), stating that a leave of absence has been granted and that you will be returning to your current job. The Employment Letter must be addressed to Guyana High Commission. If you are self-employed, include a copy of your business license and tax return. If you are retired please submit proof of your retirement fund.

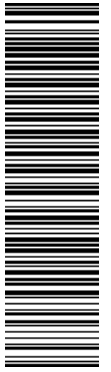

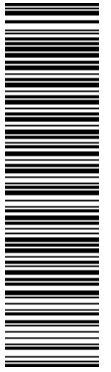
