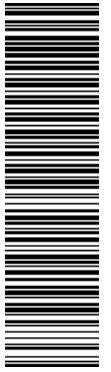

As of May 1st 2022, until further notice, the embassy has forced to stop issuing passports and Visas, of any variety, to Israel.

**Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.

**Photograph. 1** One current passport photo, 50mmx50mm (2"x2") and taken by a professional photographer, on a white background.

**Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.

☐

**Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.

☐

**Proof of Status.** Original ILR card or other proof of resident status in the UK, this should be valid for a minimum of six months upon date of entry to Israel.

☐

**Itinerary.** Copy of round trip **tickets or confirmed itinerary.**

**Health Insurance.** Proof of health insurance covering international travel.

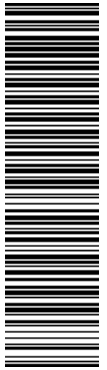

**Bank Statement.** Copies of original bank statements from the past 3 months (no online statements accepted).

**Hotel Reservations.** Copy of confirmed hotel reservations including name of the applicant, name and address of the hotel, duration of stay.

If you are self-employed, include a copy of your business license and tax return. If you are retired please submit proof of your retirement fund.

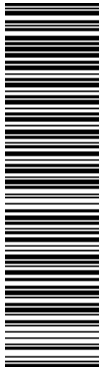

## Declaration הצהרה

אני מצהיר/ה שהפרטים שנמסרו לעיל נכונים ונמסרו בהכרה שהם מהווים יסוד לדיון בבקשתי. כמו כן, אני מצהיר בזה שלא עברתי עבירה פלילית. לא פעלתי נגד העם היהודי וביטחון מדינת ישראל. לא חליתי במחלה העלולה לסכן את בריאות הציבור. לא קיים נגדי צו מעצר שיפוטי ואינני מבוקש על ידי המשטרה של מדינה כלשהי.

אני מצהיר/ה בזאת שלא קיים נגדי צו הרחקה ולא סירוב כניסה לארץ, ידוע לי שאם יש נגדי מניעה כאמור, תימנע ממני אפשרות להיכנס לישראל ואוחרזר למדינה שממנה הגעתי.

ידוע לי שאין בקבלת האשרה משום ביטול סמכות משרד הפנים בישראל, לסרב כניסתי לתחומי מדינת ישראל, אם יסתבר שהאשרה התקבלה על סמך פרטים כוזבים.

I declare that the particulars contained in this application are correct and I am aware that they serve as the basis upon which my application will be considered. I also declare that I have not committed any criminal offence or any act directed against the Jewish people or the security of the state of Israel and that I am not affected with any illness which may endanger public health. There is no judicial warrant against me and I am not wanted by the police of any country.

I hereby declare that I have not been issued with a restraining order. Furthermore, I have not been denied entry into Israel. I am aware that if a preventive order of this kind has been issued against me, I will be denied entry into Israel, and will be sent back to my country of origin.

I am also aware that the receipt of a Visa does not in any way invalidate the authority of the Israel Ministry of the Interior to deny my entry into the territory of the State of Israel, if it becomes clear that the Visa was issued on the basis of false information.
