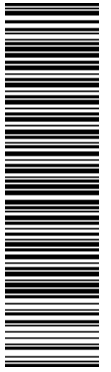

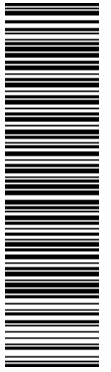


Japan tourist visa checklist

- Filled out and signed Japan tourist visa application form.** The form is enclosed.
- Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- Photo:** One photograph, size 2x2 (taken within last 6 months)
- Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- Itinerary.** Copy of **round trip tickets or itinerary.**
- Bank Statement.** Copy of a recent bank statement showing proof of sufficient funds.
- Hotel Reservations.** Copy of confirmed hotel reservations including name of the applicant, name and address of the hotel, duration of stay.
- Letter of Invitation.** An official letter of invitation approved by the Ministry of Foreign Affairs in Japan.
- Schedule of Stay.** Schedule of stay (Japanese or English) for the proposed trip. This form is available here.

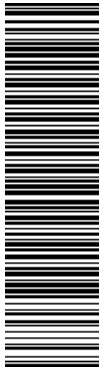

Retained Personal Information will only be used to the extent necessary for the purpose of processing the visa application (including providing personal information to the transportation company which you are going to travel with, or the alternative transportation company which you are going to travel with due to unforeseen circumstances), immigration control, international cooperation and for other purposes in compliance with Article 69 of the Act.
