### Japan tourist visa checklist



**Filled out and signed Japan tourist visa application form.** The form is enclosed.



**Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.



**Photo:** One photograph, size 2 x 2 (taken within last 6 months)



**Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.



**Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.



**Proof of Status.** Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Japan.



**Itinerary.** Copy of **round trip tickets or itinerary**.



**Bank Statement.** Copies of original bank statements from the past 3 months (no online statements accepted).

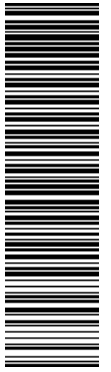


**Employment Letter.** An original letter from your employer/school (on business letterhead, with contact details), stating that a leave of absence has been granted and that you will be returning to your current job. The Employment Letter must be addressed to Japan High Commission. If you are self-employed, include a copy of your business license and tax return. If you are retired please submit proof of your retirement fund.



**Hotel Reservations.** Copy of confirmed hotel reservations including name of the applicant, name and address of the hotel, duration of stay.

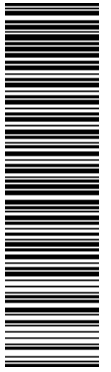
