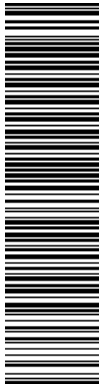

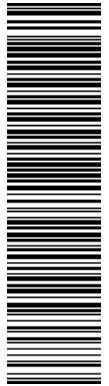
The processing of Saudi Arabia Visa via the embassy in London has restarted and we are able to help with processing for Business and Commercial visas for UK nationals and applicants living in the UK.



### Saudi Arabia business / commercial visit checklist

- ☐ **Filled out and signed Saudi Arabia business / commercial visit application form.** The form is enclosed.
- ☐ **Original Djibouti Passport.** Valid for six months or more and must have two blank pages facing each other.
- ☐ **Passport-type photos.** 2 Passport size pictures for each applicant.
- ☐ **Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- ☐ **Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- ☐ **Original Proof of Status.** An original ILR card or other original proof of resident status in the UK, this should be valid for more than 6 months after your return from Saudi Arabia.
- ☐ **Supporting letter from employer.** Supporting letters from UK employer must be certified by London Chamber of Commerce (LCCI). VisaHQ can assist with the certification. This requires additional Formal Undertaking Form to be completed by the SIGNEE of the letter and posted to us in original. It takes for us 24 hours to certify the letter at total cost of £74.20+VAT, which includes £35 our handling fee or you can do it yourself. Information from your invitation **MUST** be correctly included into your business letter. Please see both letter template and Undertaking form attached.

☐ **Invitation letter.** Must be organised by the inviter through either local Chamber of Commerce or the Ministry of Foreign Affairs. When filing invitation request the sponsor needs to state applicant's employer - this must be the same company providing supporting letter for actual visa application.

- For **female applicants** invitation must be issued by the Ministry of Foreign Affairs.

- **Applicants of Arabic origin** if travelling during the Hajj or Umrah must present invitation issued by the Ministry of Foreign Affairs.

- **Self-employed applicants** must be supported by a letter from UK registered company.

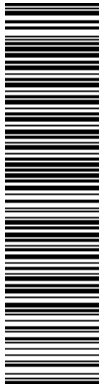
☐ **Proof of Medical Insurance.** Medical insurance from the list of provided suppliers. This form is available here.

☐ **Flight itinerary.** All applicants applying for a Saudi visa, must provide a copy of their flight itinerary. Applicants must be in the UK when applying for the visa. Please make sure the flight itinerary reflects departure from UK.

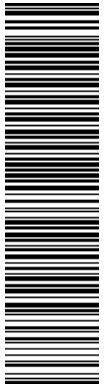

I, the undersigned, hereby agree to have my fingerprint & iris data (biometrics) captured as part of the application procedure for an entry visa to the Kingdom of Saudi Arabia. I further agree and declare as follows:

1- I acknowledge that all of the information I provided are true and reliable. In addition, I pledge to abide the laws and rules of the Kingdom of Saudi Arabia, and respect the customs and Islamic traditions of its people during my stay. I acknowledge my understanding that the specialized authorities in the Kingdom of Saudi Arabia have the right to deny my entry and to send me back to where I came from if I did not comply with the rules and laws, or if the information under which I received my visa proven to be incorrect.

2- I am fully aware that all intoxicating substances, narcotic drugs, indecent materials and publications, as well as publications related to any religious beliefs or political tendencies that contradict with Islam are prohibited in the Kingdom of Saudi Arabia.

3- I am fully aware of the procedures and controls regarding the batch-release and clearance of medicines, containing narcotic or psychotropic substances that are possessed for personal use by patients arriving and departing from The Kingdom , such procedures and controls are provided in the link below:

4- I have never been deported from The Kingdome of Saudi Arabia or any other GCC countries, nor have I violated their rules.

5- I pledge to stick to the kind of visa I was provided with and to its terms and duration, and I shall leave the country before the stay specified in the visa expires. I am also fully aware of my violation to the rules in the Kingdom or entry visa shall subject me to a penalty and the application of punishments stipulated by the laws regulating the process of handling people coming to the Kingdom with visas for Hajj or Umrah and others issued by Royal Decree No (m / 42) , on 18 / 10 / 1404 H and amended by Royal Decree No (m/9) on 1/5/1420 H, as well as sanctions on violators of residency and work regulations promulgated by the Council of Ministers resolution No (140) on 6/5/1434 H. .

6- I acknowledge the right of Saudi authorities to repatriate me from the port of entry at my own expense or deport the Saudi territory after entering it, and I acknowledge the right of the Saudi authorities to apply the penalties provided by Law if proven that after I got my visa or residence permit , I have submitted incorrect papers or documents or provided false statements to any Saudi competent authority at home or abroad in order to obtain for myself or for someone else a visa for entry or residence permit or any other official visa or being a contributor or partner in providing such information or documents that do not match the truth.

7- I acknowledge that drug dealing or smuggling drugs into the Kingdom is a crime punishable by death penalty.

8- I acknowledge and pledge again that all written information shall be correct and I take full responsibility for it, and if it is proven otherwise -or my name appears to be included in a list specifying the prohibited people - , then my request shall be rejected, or my visa shall be cancelled automatically if it is granted, or I shall not be allowed to enter the Kingdom of Saudi Arabia if I had a valid visa. Moreover, I acknowledge the right of Saudi authorities to deport me back to the port of entry at my own expense and I shall not have the right to claim compensation.
