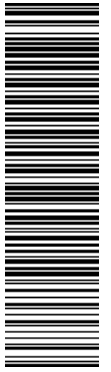

For the holders of a valid UK residency permit or a UK visa (biometric card)

If you hold a valid UK residency permit or a UK visa (biometric card) permitting you to return to UK, **you may enter Serbia without a visa and stay for 90 days within a 6 month period.**

**Please be advised** that your stay should not exceed the dates stated in the UK residency permit/visa. Furthermore, please note you must carry your permit card with you as well as your passport, and present it upon request by the immigration authorities.

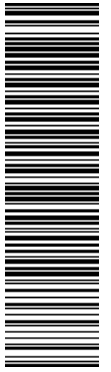
Free entry is allowed only if you have valid passport with valid resident permit (Visa) inside valid passport or with Resident permit card. These persons can **not** request temporary stay in the Republic of Serbia. Persons with a stamp in their passports allowing them to reside in the UK **may not automatically be allowed to enter** the Republic of Serbia.



### Serbia tourist visa checklist

- Filled out and signed Serbia tourist visa application form.** The form is enclosed.
- Passport:** Valid passport (passport must be valid at least 90 days from issue date of visa).
- Photo requirements.** Recent (size 3.5x4.5cm) coloured photograph.
- Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- Proof of Status.** Scanned copy of ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Serbia.
- Itinerary.** Copy of round trip **tickets or confirmed itinerary.**
- Proof of payment.** A proof of payment for the trip issued by a travel agency (voucher or other types of payment receipt).

- Health Insurance.** Proof of health insurance covering international travel.

---

- Bank Statement.** Copy of a recent bank statement showing proof of sufficient funds.

---

- Driver's License.** A copy of an international driver's license along with title and insurance documents(copy)are required if the applicant is travelling by car.

---

- Employment Letter.** A letter from concern employer of Serbia mentioning the applicant's position in the organization.

---

- Personal Invitation.** If staying with friends or family, a letter of invitation from the host in Serbia, NOTARIZED by the appropriate city hall in Serbia can be used instead of the hotel reservation.

---

- Hotel Reservation.** A hotel booking reservation must be on an official letterhead and signed by a manager.

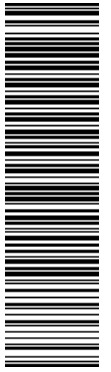

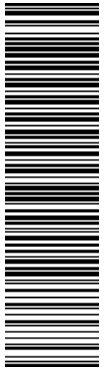
