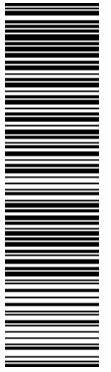

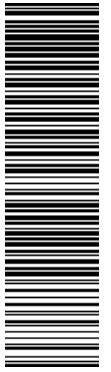


Singapore tourist visa checklist

- ☐ **Filled out and signed Singapore tourist visa application form.** The form is enclosed.
- ☐ **Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- ☐ **1 Photographs.** Standard passport photographs 35mm x 45mm on a white background.
- ☐ **Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- ☐ **Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- ☐ **Proof of Status.** Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Singapore.
- ☐ **Itinerary.** Copy of **round trip tickets or itinerary**.
- ☐ **Hotel Reservations.** Copy of confirmed hotel reservations including name of the applicant, name and address of the hotel, duration of stay.
- ☐ **Invitation form and copy of ID card.** If being invited to Singapore by friends or family they must be permanent residents in Singapore (work permit does not count as permanent), fill the Invitation form and include a copy of their ID card.
- ☐ **COVID-19 PASS.** Printed digital copy of the NHS COVID-19 PASS.

☐ **Singapore Arrival Card with Electronic Health Declaration.** Apply here or install the MyICA Mobile app for Android and Apple phones. This is not a requirement for your visa application but is required prior to traveling to Singapore.

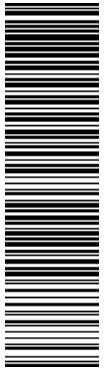

I understand that if the Controller of Immigration is satisfied that I or any member of my family breaches this undertaking or becomes an undesirable or prohibited immigrant, he will cancel my immigration pass and the passes of the members of my family, and we may be required to leave Singapore within 24 hours of such cancellation.

I understand that this application for and possession of a visa does not guarantee entry into Singapore and permission to entry is entirely discretionary at the point of entry.

I give my consent for your department to obtain and verify information from or with any source as you deem appropriate for the assessment of my application for immigration facilities.
