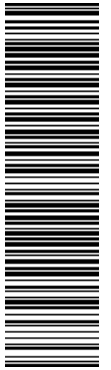

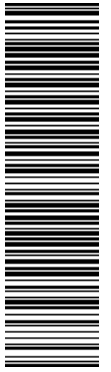

### Singapore tourist visa checklist

- ☐ **Filled out and signed Singapore tourist visa application form.** The form is enclosed.
- ☐ **Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- ☐ **1 Photographs.** Standard passport photographs 35mm x 45mm on a white background.
- ☐ **Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- ☐ **Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- ☐ **Itinerary.** Copy of **round trip tickets or itinerary**.
- ☐ **Hotel Reservations.** Copy of confirmed hotel reservations including name of the applicant, name and address of the hotel, duration of stay.
- ☐ **Invitation form and copy of ID card.** If being invited to Singapore by friends or family they must be permanent residents in Singapore (work permit does not count as permanent), fill the Invitation form and include a copy of their ID card.
- ☐ **COVID-19 PASS.** Printed digital copy of the NHS COVID-19 PASS.
- ☐ **Singapore Arrival Card with Electronic Health Declaration.** Apply here or install the MyICA Mobile app for Android and Apple phones. This is not a requirement for your visa application but is required prior to traveling to Singapore.

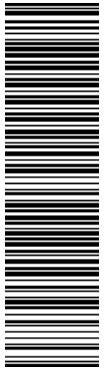

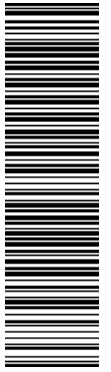
