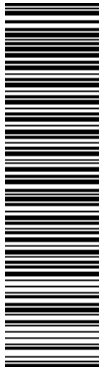

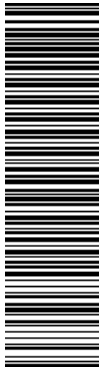
All arriving passengers are required to adhere to the Health Protocols/Guidelines that are applicable at the time of arrival.



### Sri Lanka tourist visa checklist

- ☐ **Filled out and signed Sri Lanka tourist visa application form.** The form is enclosed.
- ☐ **Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- ☐ **2 Photographs.** Standard passport photographs 35mm x 45mm on a white background.
- ☐ **Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- ☐ **Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- ☐ **Proof of Status.** Scanned copy of ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Sri Lanka.
- ☐ **Passport copy.** Photocopy of the bio-data page of applicant's passport.
- ☐ **Negative COVID-19 test result.** An applicant must provide a negative PCR Covid 19 test 72 hours before arrival.
- ☐ **COVID-19 Test Result.** Be tested again upon arrival. A third test will be given on day 7.
- ☐ **Additional Requirements.** All travelers must apply for an online visa and commit to a minimum of 14 days in the country.

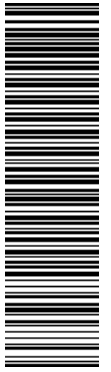

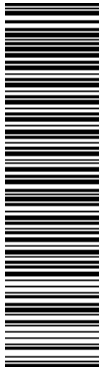
