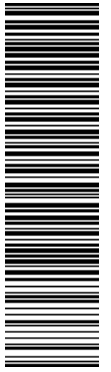

Return mailer. Prepaid self-addressed return label or payment for Royal Mail.



Proof of Status. Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Tajikistan.



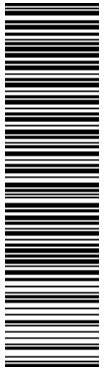
Itinerary. Copy of **round trip tickets or itinerary**.

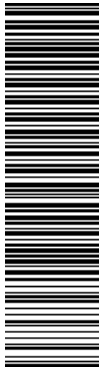

Please note: Kuhistoni Badakhshon Autonomous Province of Tajikistan (GBAO) is the frontier territory of Tajikistan and has special permission entry (a stamp, which comes on a separate page of passport), which allows applicants to visit Khorugh, Darvoz, Vanj, Rushon, Ishkoshim and Murghob districts. Foreign citizens traveling to GBAO region should indicate in their application, under the section of 21 "purpose of visit" their intention to do so. Additional Embassy fee for GBAO permit is £50.

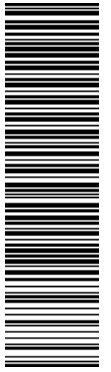
