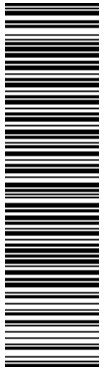

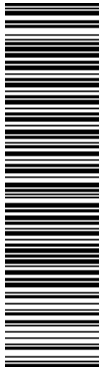
IMPORTANT: Please note that all the applicants of all ages are required to attend an appointment at the Consulate in London to give their biometric data.



Tajikistan tourist visa checklist

- Filled out and signed Tajikistan tourist visa application form.** The form is enclosed.
- Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- 1 Photographs.** Standard passport photographs 35mm x 45mm on a white background.
- Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.
- Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.
- Proof of Status.** Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Tajikistan.
- Itinerary.** Copy of **round trip tickets or itinerary**.
- Hotel reservation.** Copy of confirmed and fully paid hotel reservations including the name of the applicant, name and address of the hotel, duration of stay.

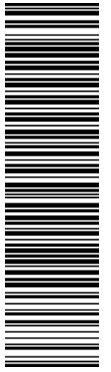

Please note: Kuhistoni Badakhshon Autonomous Province of Tajikistan (GBAO) is the frontier territory of Tajikistan and has special permission entry (a stamp, which comes on a separate page of passport), which allows applicants to visit Khorugh, Darvoz, Vanj, Rushon, Ishkoshim and Murghob districts. Foreign citizens traveling to GBAO region should indicate in their application, under the section of 21 "purpose of visit" their intention to do so. Additional Embassy fee for GBAO permit is £50.
