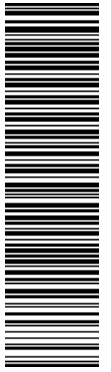

### Tajikistan tourist visa checklist

**Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.



**1 Photographs.** Standard passport photographs 35mm x 45mm on a white background.



**Payment.** Credit Card Authorization form, Postal Order payable to **VisaHQ.co.uk**.



**Return mailer.** Prepaid self-addressed return label or payment for Royal Mail.



**Proof of Status.** Original ILR card or other proof of resident status in the UK, this should be valid for more than 6 months after your return from Tajikistan.

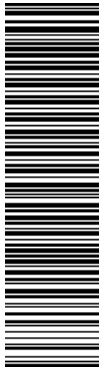


**Itinerary.** Copy of **round trip tickets or itinerary**.



**Hotel reservation.** Copy of confirmed and fully paid hotel reservations including the name of the applicant, name and address of the hotel, duration of stay.

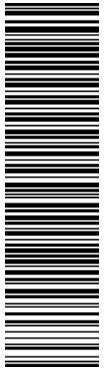

Foreign citizens traveling to GBAO region should indicate in their application, under the section of 21 "purpose of visit" their intention to do so. Additional Embassy fee for GBAO permit is £50.

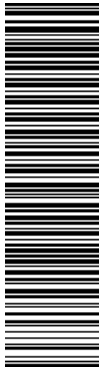
