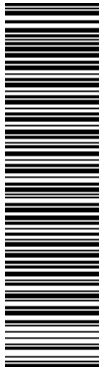

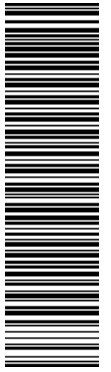
Return mailer. Prepaid self-addressed return label or payment for Royal Mail.

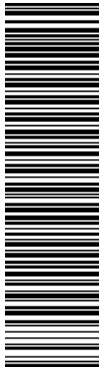

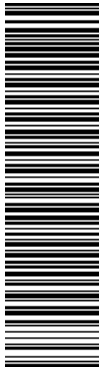

(c) The period of stay in Zambia shall be determined by an Immigration Officer at the port of entry.
